### **EXECUTIVE SUMMARY**

The Nigerian Citizen Association South Africa (NICASA) 2023 election was conducted on the 9th of September 2023, at the Nigerian Consulate in Johannesburg, with a total of 12 positions to be filled. The positions are: President General, Vice President I and II, Secretary General, Deputy Secretary General, Treasurer, Organising Secretary, Deputy Organising Secretary, Financial Secretary, Chief Protocol Officer, Deputy Protocol Officer and Public Relation Officer (PRO). The election was carried out through an open secret ballot, ensuring privacy of eligible voters and transparency of the election process. The report reveals that out of the 188 delegates, 152 (80%) were accredited to take part in the election. 10 delegates from Eastern Cape were disallowed to take part in the election due to allegation of non-existence of NICASA branch in the Eastern Cape Province. The number then dropped to 142. Out of the 142 accredited delegates, 121 (85%) cast their votes for the election.

All candidates and voters had equal access to information and opportunities to express their preferences. The election committee diligently monitored the process, addressing any concerns promptly and maintaining the integrity of the election. The report provides a breakdown of the election results, highlighting the successful candidates for each position. The report identifies a few challenges faced during the election, such as delay in the start of the election due to the Eastern Cape delegates' eligibility. Recommendations are made to address these challenges and further enhance the election process in future years.

The NICASA 2023 Election Report demonstrates the association's commitment to upholding democratic principles and ensuring a fair and transparent election process. As NICASA moves forward, these findings and recommendations will serve as valuable insights to continuously improve its election procedures, ultimately strengthening the association's governance and service to its members.

### INTRODUCTION

The NICASA Independent Electoral Committee (NIEC) made up of the Chairman; Dr. Lawan Abdulhamid, Secretary; Engineer Emmanuel Ukpoju (PhD) and five (5) members; Archbishop Chidiebere Ogbu (PRO), Chief Benson Nwaogwugwu, Hon. Angel Chizoba Omozogie, Chief Prince Akukalia, and Hon. Sunny Atiti, inaugurated by the NICASA executives was tasked with the responsibility of conducting a free, fair and credible elections for the organization in 2023. In view of this, the committee released the Terms of Reference (ToF) and the guidelines for the conduct of the elections.

Information on the eligibility criteria, how to contest, position and cost of forms was widely publicised among members, and interested candidates were screened for the publicised positions, which included the positions of the President General, Vice president 1 and 2, Secretary General, Deputy Secretary General, Financial Secretary, Treasurer, Organizing Secretary, Deputy Organizing Secretary, Chief Protocol Officer, Deputy Chief Protocol Officer, and Public Relations Officer (PRO).

The election was successfully held on Saturday the 9th of September 2023 at the Nigeria Consulate Johannesburg, and votes cast were publicly sorted and counted, and the winners were declared at venue on the same day and issued certificate of return.

### **Pre-election Matters**

In preparation for the 2023 NICASA general elections, the NIEC sort to conduct an election that beyond free, fair and credible, is inclusive of the major established socio-cultural groups, religious associations and professional organizations of Nigeria extraction in South Africa. Thus, the committee came up with its Terms of Reference (ToF) specifying the number of delegates (188) to be selected from all identified groups, who would be casting their votes at at the poll. The following groups were represented (see attached 2023 NICASA election infographic- Appendix 1)

Each of the identified group, with the exception of NICASA BOT (15) and NICASA provinces (10 each), NNISA (10) ODUA (10) and ONSA (10) was required to present 5 delegates. All contestants and NICASA executives were also included as delegates bringing the total number of delegates to 188, for the elections. Similarly, nomination fee was specified for each position stated. The fees were allotted as follows:

Other elements of the TOR also included eligibility criteria, which stipulated that all contestants must be a passport carrying citizens of Nigeria, who are residing in South Africa and are having a valid resident permit. They must have a legitimate and provable means of livelihood; be of noble character and without a history of criminal conviction and have proven record of community service engagement. In addition, the term of office for the elected officers was specified for a 4-year term, as per the constitution, with the clause that it could be reduced to 3 years after the constitution amendment by the incoming executives. To ensure gender balance three positions were specifically reserved for female candidates. These are; Treasurer, Deputy Organising Secretary and Chief protocol officer. This does not exclude them from contesting in other positions.

### Online expression of interest form

The NIEC released a link for an online expression of Interest using Jotform. Contestants were required to attach the following documents: Nigerian Passport, Valid Resident Permit, two reference letters, letter of motivation and proof of payment for the form. All contestants' documents were confidentially handled without allowing anyone outside the NIEC access to them. The online form was extended twice to allow all vacant positions to be filled in. In each case information was released with clear date of open and closure of the form to the public through various Nigerian Associations WhatsApp groups.

### Screening of candidates

Seventeen (17) candidates were screened at the Nigerian consulate in Johannesburg. In the screening exercise we first checked the authenticity of the document submitted by scrutiny of the original document presented during the screening. All contestants were asked to fill in Pledge letter agreeing to peaceful conduct during the election (see Appendix 2) using the online expression of interest forms provided electronically, and the criteria enumerated for the positions. At the end of the screening, there were four (4) contested positions; President General, Vice President 1, Treasurer and Organizing Secretary. For other positions, candidates were unopposed.

### **Election guidelines**

Certain guidelines were set for the delegates and candidates to ensure a smooth conduct of the elections. Some of which indicated the type of election to be conducted, which is the simple majority. As for the contested positions, a candidate will be declared winner and returned elected. Meanwhile, candidates vying for the unopposed positions, must each secure 25% of the total votes cast to be declared winner. Additionally, contestants are to be listed as delegates to enable them to cast their votes. Specified in the guideline also, is the allotted time for the accreditation of delegates, slated for 8:00am to 9:30 am, and to be followed by a manifesto session by candidates. All candidates were required to come to the election venue with either the original Nigerian passport booklet or a coloured copy of the biodata page of their Nigerian passport, to gain access to the venue, and only confirmed delegates would be admitted into the vicinity of the Nigeria consulate, the venue of the election. Among other things, the guideline also barred campaigns by contestants on the election day. (For the comprehensive list please refer to the guidelines attached herein as Appendix 3).

### **Petitions and Withdrawals**

A couple of petitions were received from some contestants, provinces, Organizations and well-meaning Nigerians regarding the eligibility of certain candidates. These allegations were based on membership status of some contestants in NICASA and other Organizations, discrepancies in educational qualifications. These were dealt with and a resolution to allow all contestants to partake in the election was agreed. Consequent upon this, the AYIDSA community pulled out of the election citing an error of judgement on the part of the IEC. Also, the Nigeria Doctors Forum withdrew citing lack of mandate from their members to partake in the election.

### **ELECTION DAY**

The election was held on Saturday, the 9th of September 2023 at the premise of the Nigeria Consulate Johannesburg. The IEC accredited 152 delegates for the election. This is inclusive of 10 delegates from the Eastern cape. However, a decision was made to withdraw the 10 delegates from eastern Cape after series of debates concerning their eligibility. Thus, the total number of delegates dropped to 142. Nonetheless, only 121 voted in the elections. Votes were casted, sorted and counted publicly, and results were announced immediately on the same day and venue. Below is the breakdown of the votes and winners: Akanbi Kazeem Ganiyu, one of the contestants for the President General was allegedly withdrawn from the election few minutes before the commencement of the voting.

### FINANCIAL REPORT

NIEC was mobilised by NICASA to the sum of R40,000 to perform its responsibility of conducting the NICASA 2023 elections. Through the sale of the Expression of Interest (EOI) forms, the committee realised the amount of R45,000 paid by the 17 contestants directly to the NICASA National Bank Account. The overall breakdown of the financial report including the income and expenses is detailed as follows:

The committee therefore remitted to the NICASA bank account the balance of R9,244.39. (see Appendix 4)

It is worthy of mention that the hosting of the online jotform access for the expression of interest form wasn't budgeted for. Nevertheless, the committee chairman; Dr. Abdulhamid Lawan graciously took up the task at a cost of R7000 without refund. This is a measure of the committee's selfless disposition to the given task.

### **APPRECIATION**

The NIEC committee wishes to extend its gratitude to the Consul General; Hon. Andrew Idi and the entire Consulate staff for their selfless service especially on the day of the election and also in the provision of refreshment for the entire delegates who had come from far and near. Also, worthy of mention is the Nigeria's High Commissioner to South Africa; Amb. Haruna Manta for his fatherly guidance.

### OBSERVATIONS AND RECOMMENDATIONS

The process leading up to the election, including the conduct of the election was generally peaceful. This election marked a watershed in the history of NICASA. It is the first time that the leadership of NICASA will have five (5) women in its fold. This is hugely encouraging and commendable. However, certain issues are to be highlighted, and recommendations are thus, made in effect.

- Clarity of Membership: There is a need for the Constitution of NICASA to be reviewed to correct membership ambiguity. NICASA should as a matter urgency have a Registration Directory.
- Imbalance in Regional and Provincial Representation: Key offices in NICASA National should be zoned across geopolitical divides and Provinces. This will motivate other regional blocs to fully commit to strengthening NICASA.
- Provincial Relevance: National Elections to be moved within Provinces to encourage and enhance general participation in NICASA National functions.

### CONCLUSION

On the 9th of September 2023, NICASA successfully held its general election at the Nigerian consulate, Johannesburg. The election had 142 delegates, whose votes ushered in the new sets of executives, through a simple majority vote. While certain positions were fiercely contested, others were largely unopposed. However, each unopposed candidate was required to gain 25% of the total votes cast, to be declared a winner. Although participation was impressive, there is a need for a more balanced representation of the different regions in Nigeria.

### 2023 NICASA Election Guidelines

The Independent Electoral Commission for the NICASA 2023 elections wishes to inform all the delegates and contestants of the following guidelines for the 9 September 2023 elections at the Nigerian Consulate in Johannesburg.

- 1. There are four contested positions: President General, Vice President 1, Organising Secretary and the Treasurer. With a simple majority, a candidate will be declared the winner of the election and will be returned elected.
- 2. There are eight unopposed positions, a candidate will be declared a winner and returned elected only when he/she gets at least a quarter (25%) of the total votes cast. Otherwise, the position will be declared vacant.
- 3. All contestants shall be listed as delegates, this will enable them cast their votes.
- 4. Accreditation of delegates will be from 8:00 9:30 a.m. This will be followed immediately by a manifesto session by all contestants.
- 5. Light refreshments will be served to all delegates on the day of the election. Delegates from provinces outside Gauteng are strongly advised to arrive in Johannesburg on Friday.
- 6. No campaign will be allowed on the day of the election.
- 7. ONLY delegates will be allowed into the Consulate premises for the elections.
- 8. All voting delegates must come along with their Nigerian passport booklets or coloured copies for proper identification.

NIEC would like to reassure the Nigerian community of its readiness to conduct a credible, free, and fair election.
